SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Approves certain new or increased fees adopted by State Department of Agriculture. Declares emergency, effective July 1, 2011.
